This report is designed to give our member councils an overview of the financial health of our organization. Just like the local councils we serve, the national organization is dedicated to conservative stewardship of the member dues and fees we receive and services we provide.

The board of directors continues its work to build a reserve of one year of operating expenses, which will ensure that the organization is stable for many years to come.

As of the date of this report, September 30, 2016 we have a total balance sheet of \$553,522 of which \$117,952 is board designated to the AEP® committee for marketing and promotional purposes.

Multi-Disciplinary Teaming and Professional Collaboration Committee Report S. Mark Alton, CFP®, ChFC®, CLU®, CAP®, AEP®, MSFS, CPWA®, Committee Chair Charlie Douglas, JD, CFP®, AEP®, Committee Vice-Chair

Estate planning is a highly complex multi-disciplinary endeavor, and when done most successfully engages the services of a high-performance team of designated professionals who work together in close collaboration.

However, true collaboration doesn't come easily, and it doesn't happen naturally. It requires strong leadership.

One of the advisors must take the lead, and initiate the process. Then, the group must simultaneously engage in cooperation, coordination and communication. While each of these three aspects is important, to collaborate at a high-level the team must do all three, and do them all well.

The key to success starts with developing and then implementing an explicit process, one that can be articulated out loud to the wealth holder(s) and to his or her family, as well as to each and every member of the professional advisor team.

The formation of this committee is clear evidence of NAEPC's long-term commitment to promoting the multi-disciplinary team approach to estate planning. However, real progress will only come from your leadership.

The strength of our organization lies in its affiliated local councils and their members. We encourage you to foster substantive conversation around this topic at your local council meetings, and to create practice fields that effectively facilitate experiential and seamless multi-disciplinary collaboration.

We have provided various tools and resources for your reference that can be found at <a href="www.naepc.org">www.naepc.org</a> under the "Guide to Teaming" tab. They include a whitepaper and a facilitator's guide that you can use to lead a local initiative. You might consider doing this through breakfast discussion groups, study groups or monthly meetings. We have seen this work well using case studies, films, or even something as simple as formulating a list of questions. Then we recommend getting together in small, multi-disciplinary groups and engaging in dialogue around the subject matter.

We are actively seeking feedback and best practices. Please consider sharing your experiences with our committee so that we can share them with our full membership.

The NAEPC Webinar Committee has completed three years of monthly webinars; bring to our member councils and their members "the best of the best, of the best" in speakers and topics, as prescribed by its originator, Robert (Bobby) Alexander. Our attendance has grown by 65% in the second year and by 112% in the past year. The list of outstanding professionals who have volunteered their time and expertise is remarkable. They have created one of the finest archives of professional estate planning content anywhere in the world. We thank all of you, especially our speaker volunteers, for your interest, involvement and support.

The one-hour programs are typically offered monthly on the 2<sup>nd</sup> Wednesday at 3:00 ET, excepting the November conference month. Nearly all webinars are archived for playback at the listener's convenience. They have become a favorite for many councils as a group learning/discussion activity and even as the monthly program allowing the members to hear from experts who are otherwise difficult or impossible to schedule.

Continuing education credit is available at each webinar for Accredited Estate Planner® designees. In addition, a certificate of completion will be made available for those professionals who feel the program satisfies their continuing education requirements and are able to self-file. Councils may also file the program in their home state for programs offered in a group setting.

The registration fee is only \$40 for Accredited Estate Planner designees whose dues are current, \$60 for members of an affiliated local estate planning council or at-large members of NAEPC, \$100 for individual non-members, and \$250 for a council meeting or group gathering for councils whose annual dues are current.

Our volunteer committee works hard to provide fantastic value and outstanding performance of the site, which for most users is the central point of communication for monthly meetings, dues payments, and maintaining the strong bond between the local councils and national association.

We continue to make advancements in all areas of our website technology, and it's been well received as we have again hit new highs in the number of councils using our service, as well as increased usage of the level III and IV platforms.

Our affiliated councils remain the best source for new features and enhancements. The committee monitors and measures success via a "development agenda" that prioritizes

improvements to both the national and local council sites. We also often enlist the help of member councils to "beta test" enhancements before rolling out the improvements to all users. Security has been and will remain a priority as well, and we are proud of our legacy in this area.

We continue to communicate new features of the service via announcements in the administrative login area of the site, and our webmaster also gets great feedback and recommendations via face to face meetings at the conference. Here is a sample of the new features released during 2016:

- Option to use member email addresses as usernames
- Members can view, edit or cancel event RSVPs
- Admin can cancel a member's RSVP
- Admin can see all activity for an individual member
- Admin can record show/no-show status for each event attendee
- Admin can edit existing RSVPs
- Admin can manually create RSVPs for members
- Councils can now forward NAEPC News newsletter to members
- Communication to predefined groups for active members of each discipline

We plan to focus the bulk of our work during 2017 on the enhancement of the dues renewal system, a much-requested set of features by many EPCs.

I am extremely grateful for the contributions of our committee members, with special recognition to our long-serving webmaster, Bruce Newburger. Please join me in thanking the entire committee as you see them at the annual conference.
